KIDS FUN PASS

Terms and Conditions

1. These terms and conditions apply to participants in the 'Kids Fun Pass' Centre Promotion ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The "Promoter" is Dexus Shopping Centres Pty Ltd (NZBN 9429036747153). The address is 588 Chapel Road, East Tāmaki, Auckland 2016, New Zealand.
3. This Promotion will be at Botany Town Shopping Centre, 588 Chapel Road, East Tamaki, Auckland 2016, New Zealand. (09) 272 3888 ("Centre").

ELIGIBILITY

4. This Promotion is only open to residents of New Zealand who are able to attend the Centre during the promotion.
5. The following individuals are ineligible to enter the Promotion:
 - a. employees, directors, officers and management of the Promoter, any related bodies corporate of the Promoter, or any of the tenants or retailers in the participating Centre/s or any of the Promoter's agencies that are associated with the Promotion;
 - b. the spouse, de facto spouse, parent, child or sibling of an individual listed in paragraph a.; and
 - c. any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

PROMOTION PERIOD

6. The Promotion commences at 9.00am NZST on Monday 29th June 2026 and ends at 6.00pm NZST on Sunday 19th July 2026 ("Promotion Period"). Kids Fun Passes are available to purchase during the Promotion Period and are valid for redemption between Monday 6th July – Friday 31st July 2026.

HOW TO PURCHASE

7. To purchase a Kids Fun Pass, during the Promotion Period:
 - a. Visit the Botany Town Centre website at www.botanytowncentre.co.nz and click on 'purchase tickets here' link on the Kids Fun Pass landing page. This will link through to the Humanitix event page where purchasers will be able to login and purchase their passes. Kids Fun Passes are only available to purchase online between Monday 29 June – Friday 31 July 2026, and while stocks last.
 - b. A confirmation email will be sent to the purchaser with the purchase details. Present this email with photo ID to the Botany Customer Service Desk during centre hours to pick up the Kids Fun Pass vouchers.

8. Once a purchase is made by the Purchaser, the Purchaser acknowledges that the Promoter's decision in relation to any aspect of the Kids Fun Pass is final and binding. Refunds will not be provided except as required under applicable consumer law.
9. Purchases are only open to visitors of Botany Town Centre. All purchasers must be 18 years of age to purchase and redeem Kids Fun Passes. Users of the Kids Fun Pass vouchers can be up to and including 15 years of age.
10. The total price for the Kids Fun Pass is \$15 and includes the Humanitix booking fee and GST. All prices and values of the Kids Fun Pass are in New Zealand Dollars. Once the purchase has been made via Humanitix, a validation email will be sent to the Purchaser to confirm the order.
11. There is a limit to 5 Kids Fun Pass purchases per order. The promotion is while stocks last. There are 5,000 Kids Fun Passes for sale in total.

HOW TO REDEEM

12. To redeem the Kids Fun Passes, the purchaser must complete the following steps during the Promotional Period:
 1. Present their email confirmation, as provided in Humanitix, with photo ID to a staff member at the Botany Customer Service Desk during centre hours.
 2. Botany Customer Service Team will issue the Kids Fun Pass and mark your order as being collected.
 3. Kids Fun Passes are valid for use between Monday 6th July – Friday 31st July 2026 inclusive. Any unused passes at the end of the Promotion Period will be void. Customers must retain email confirmation as proof of purchase. Failure to produce the proof of purchase when requested may, in the absolute discretion of the Promoter, result in invalidation of all customer passes and forfeiture of any right to vouchers. The booking confirmation email must clearly specify the purchaser's name and the number of passes.

KIDS FUN PASS CONDITIONS

13. **HOYTS Botany Town Centre** – This voucher is valid for one admission only, up to 15 years of age, for all F, PG and M movies. This ticket does not guarantee a reserved seat. Seating is subject to availability at the time of redemption and is not redeemable for recliner seats or day beds. This ticket is valid until Friday 31st July 2026. This ticket is not redeemable for cash. This ticket may not be sold, exchanged or used in conjunction with any other promotion. Standard film classifications apply. Valid for use at HOYTS Botany Town Centre only.
14. **20-minute Timeplay Experience at Timezone Botany Town Shopping Centre** – Children must be accompanied by an adult. Valid until 31 July 2026. This voucher will not be extended or replaced and is not redeemable for cash. This voucher may not be sold, exchanged or used in conjunction with any other offer. Timeplay allows you to play Red and Yellow Swiper Games only. Time begins once you have tapped your card on a viable reader. No Powertickets are awarded during Timeplay. Please check timezonegames.com for more information. Valid for use at Timezone Botany Town Centre only. Subject to venue capacity.
15. The Kids Fun Pass will include food and drink offers exclusive to the pass holder. No prepaid offers for any Botany food vendor are included in the pass and will be at an additional cost. Certain retailer offers may have additional age restrictions as specified.

HOW TO REDEEM FOOD AND DRINK OFFERS

16. Each purchaser of a 'Kids Fun Pass' will receive single-use food and drink coupons from participating retailers. These coupons are distributed upon collection of the Kids Fun Pass at the Botany Customer Service Desk and must be presented to the respective retailers to redeem the offer during the promotional period. UNCLAIMED PASSES

17. Kids Fun Passes can be claimed no later than Friday 31st July 2026 9.00pm NZST.
18. Any Kids Fun Passes that have been purchased but remain unclaimed will not have extended validity or be refunded.

GENERAL

19. You must not:
 - a. tamper with the entry process (including but not limited to manipulating the system via bots, script use, or any other means to circumvent the entry process);
 - b. engage in any conduct that may jeopardise the fair and proper conduct of this Promotion;

If for any reason a successful purchaser does not pick up a Kids Fun Pass or an element of the Promotion at the time stipulated, then the Kids Fun Pass will be forfeited and will not be redeemable for cash. Any failure by you or (if applicable) your companion/s to comply with the conditions imposed by the supplier(s) may result in the prize being cancelled or withdrawn without liability for the Promoter or the supplier(s).
22. The Promoter is not responsible for any dispute between you and any person with whom you choose to, or choose not to, share the Kids Fun Pass.

If any pass (or part of any pass) is unavailable due to reasons beyond the control of the Promoter, the Promoter at its discretion, reserves the right to substitute the pass (or that part of the pass) with a voucher or part of a voucher with an equal or higher value and/or specification, subject to any written directions from a regulatory authority if applicable.

If this Promotion is interfered with or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right to the fullest extent permitted by law to (a) disqualify a participant engaging in unauthorised intervention or fraud; or (b) to modify, suspend, terminate or cancel the Promotion, as appropriate and if applicable, subject to any written directions from a regulatory authority.
26. Your purchase must be received during the Promotion Period (or as otherwise specified in these Terms and Conditions) and will be deemed to be received only when received by the Promoter. If online or SMS

claiming is available, you will receive a return message confirming your claim. You are responsible for your own costs associated with claiming. If you claim using multiple phone numbers/email addresses/addresses/aliases, you may be disqualified.

27. This Promotion is in no way sponsored, endorsed or administered by, or associated with any social media platform, including Instagram or Facebook. You provide your information to the Promoter and not to any social media platform. You completely release any relevant social media platforms from any and all liability.

PRIVACY

28. In order to conduct this Promotion, the Promoter needs to collect personal information about each entrant and may for this purpose, provide such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, if required, to New Zealand regulatory authorities. If you have marked the “opt-in” box on the entry form relating to use of your personal information for future promotional and marketing purposes by the Promoter, you consent to the Promoter using this information for promotional, marketing, publicity and research purposes, including telephoning the entrant or sending email or SMS messages provided that, as required by the New Zealand Unsolicited Electronic Messages Act 2007 (**NZ SPAM Act 2007**), the Promoter includes a functional unsubscribe facility in each direct marketing communication it sends you that you may use to opt-out of any further such communications. You also consent to receive email or SMS messages from the Promoter without any functional unsubscribe facility if they relate primarily to the conduct of this Promotion. Unless otherwise indicated by the Promoter, the Promoter may provide personal information to entities outside of New Zealand, including in the United States, Europe and the Asia-Pacific region for storage and processing.
