

BOTANY TOWN CENTRE / SPEND AND SAVE

Terms and Conditions

1. These terms and conditions apply to participants of the 'Winter Fashion - Spend and Save' Centre Promotion ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.

ELIGIBILITY

4. This Promotion is only open to residents of New Zealand aged 18 years or over who are able to attend the Centre during the promotional period NZST for a limited time to claim the gift.
5. The following individuals are ineligible to enter the Promotion:
 - a. employees, directors, officers and management of the Promoter, any related bodies corporate of the Promoter, or any of the tenants or retailers in the participating Centre/s or any of the Promoter's agencies that are associated with the Promotion;
 - b. the spouse, de facto spouse, parent, child or sibling of an individual listed in paragraph a.; and
 - c. any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

PROOF OF PURCHASE

- 11. You must keep your Qualifying Spend itemised receipt/s as proof of purchase for each of your claims. The Promoter (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including without limitation:
- a. any technical difficulties or equipment malfunction;
 - b. any theft, unauthorised access or third party interference;
 - c. any entry or correspondence that is late, lost, altered, damaged or misdirected due to any reason beyond the reasonable control of the Promoter;
 - d. any variation in the prize value to that stated in these Terms and Conditions;
 - e. any tax liability incurred by an entrant or winner; or
 - f. use of the gift,

You provide your information to the Promoter and not to any social media platform. You completely release any relevant social media platforms from any and all liability.

PRIVACY

37. In order to conduct this Promotion, the Promoter needs to collect personal information about each entrant and may for this purpose, provide such information to third parties, including but not limited to agents, contractors, service providers, gift suppliers and, if required, to New Zealand regulatory authorities.
