## **Terms and Conditions**

- 1. These terms and conditions apply to participants of the 'Kids Fun Pass' Centre Offer ("Offer"). Participation in this Offer is deemed acceptance of these Terms and Conditions.
- 2. The "Promoter" is Dexus Shopping Centres Pty Ltd (ABN 13 001 595 955). The address is 588 Chapel Road, East Tāmaki, Auckland 2016, New Zealand.
- 3. This Offer will be conducted at Botany Town Shopping Centre, 588 Chapel Road, East Tamaki, Auckland 2016, New Zealand. (09) 272 3888 ("Centre").

## ELIGIBILITY

- 4. This Offer is only open to residents of New Zealand who are able to attend the Centre during the promotion.
- 5. The following individuals are ineligible to participate in the Offer:
  - a. employees, directors, officers and management of the Promoter, any related bodies corporate of the Promoter, or any of the tenants or retailers in the participating Centre/s or any of the Promoter's agencies that are associated with the Offer;
  - b. the spouse, de facto spouse, parent, child or sibling of an individual listed in paragraph a.; and
  - c. any person who the Promoter has previously notified is not permitted to participate in the Promoter's offers.

# **OFFER PERIOD**

 This Offer commences at 9.00am NZST on Monday 23<sup>rd</sup> June, 2025 and ends at 6.00pm NZST on Sunday 13<sup>th</sup> July, 2025 ("Offer Period"). The Kids Fun Pass vouchers are valid for redemption from 9am NZST on Saturday 28<sup>th</sup> June, 2025 through until 6.00pm NZST on Sunday 13<sup>th</sup> July, 2025.

#### HOW TO PURCHASE

- 7. To purchase this Offer, during the Offer Period:
  - 1. Visit the Botany website at <u>www.botanytowncentre.co.nz</u> and click on the 'purchase tickets here' link on the Kids Fun Pass landing page. This link will click through to the Humanitix event page where Purchases will be able to login and purchase their passes. Kids Fun Passes are only available to purchase online.
  - 2. A Confirmation email will be sent to the Purchaser with the purchase details. Present this email with photo ID to the Botany Customer Service Desk during core centre hours to pick up the Kids Fun Pass vouchers.
- 8. Once a purchase is made by the Purchaser, the Purchaser acknowledges that the Promoter's decision in relation to any aspect of the Kids Fun Pass offer is final and binding. Refunds will not be provided.

- 9. Purchases are only open to visitors to Botany Town Shopping Centre. The Promoter has the right to request a proof of identification to verify the purchaser, such as a valid and current Driver's Licence or Passport. Users of the Kids Fun Pass voucher can be up to 15 years of age.

## HOW TO REDEEM

Receipts(s) must clearly specify name and the number of passes during the Promotional Period.

## UNCLAIMED KIDS FUN PASSES

19. Kids Fun Passes can be claimed no later than Sunday 13<sup>th</sup> July 2025 6.00pm NZST. Any Kids Fun Passes that have been purchased but remain unclaimed will not be refunded or the vouchers validity extended.

## GENERAL

- 20. You must not:

Nothing in these Terms and Conditions limit, exclude or modify or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act 2010 (Cth), New Zealand Consumer Guarantees Act 1993, as well as any other implied warranties under similar consumer protection laws in the State and Territories of Australia or New Zealand ("Non-Excludable Guarantees").
- 33. The Promoter (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Offer, including without limitation:
  - a. any technical difficulties or equipment malfunction;
  - b. any theft, unauthorised access or third party interference;
  - c. any claim or correspondence that is late, lost, altered, damaged or misdirected due to any reason beyond the reasonable control of the Promoter;

  - e. any tax liability incurred by a participant; or
